Style Crest®, Inc. warrants for a period of 25 years from the date of installation, to the original purchaser at the address shown on the registration slip, Style Crest Eagle Skirting to be free from manufacturing defects and will not need painting because there is no paint to chip, peel, blister or flake. Style Crest further warrants our Eagle Vinyl Skirting resists dents because of the high impact resistant vinyl used in our manufacturing and because of the strong vertical panel design. All product failure covered by this paragraph will be remedied by Style Crest, Inc. by repair or replacement of the materials found to be defective in accordance with the applicable terms and conditions of this warranty.

This warranty covers only manufacturing defects in the Eagle Vinyl Skirting manufactured by Style Crest®. The warranty does not include labor to remove or replace any of the product found to be defective. All material failures, not caused by a defect in manufacturing including, but not limited to, failures or damage resulting from faulty or improper installation, accidental or intentional damages, (example: string type grass trimmers or power mowers); fire, flood, lighting, wind-storm, hailstorm, earthquakes, acts of God, home settlement, frost heave, air pollution, improper care and normal weathering of the surface, or other caused beyond the control of Style Crest are specifically excluded from the warranty.

This warranty is valid only after registration is completed using the registration form below. Registration form must be filled out completely and signed by the original purchaser and mailed to Style Crest, Inc. within 30 days after completion of the installation.

The warranty is valid only to the original purchaser at the address shown on the registration certificate.

If you feel the Style Crest Eagle Vinyl Skirting installed on your home is not free from manufacturing defects, write to Style Crest, Inc. ATTN: Marketing Dept., 2450 Enterprise Street, Drawer A, Fremont, OH 43420, describing the claimed defect. Style Crest will reply to your letter advising the physical evidence it will require to support your claim. If Style Crest determines the material is defective according to this warranty, Style Crest will repair or replace the materials found to be defective. Style Crest reserves the right to refund the original purchase price in lieu of repair or replacement. Style Crest, Inc. further reserves the right to make changes or discontinue any of its products. In the event the products covered by this warranty are not available, Style Crest shall have the right to substitute a product that, in Style Crest's sole discretion, is of equal quality and value.

Style Crest® makes no expressed warranty except as set forth herein and shall not be liable for any incidental, special or consequential damages with respect to the Eagle Vinyl Skirting covered by this warranty. Style Crest's complete liability and the owner's exclusive remedy, is limited to repair or replacement on the basis stated herein. Some states do not allow the exclusion or limitation of incidental or consequential damages so the above limitation may not apply.
